# **Conditions of Introductory Membership**

1. 15 Month Introductory Membership (open to Ladies & Gents) shall be from their date of election until 31<sup>st</sup> January 2013 but shall not commence before 1<sup>st</sup> November 2011.
2. Introductory Members shall have no voice in the Management of the Club, nor shall they be entitled to attend any Annual or Special General Meeting of the Club.
3. The Subscription (including I.L.G.U/G.U.I., Bar & Restaurant levies) shall become due and payable upon their election to the Club. The agreed Subscription charge for 2012 is €1,000.
4. Such members shall enjoy all the current playing rights of Full Members. They may compete and win any competition with the exception of the Captain's Prize, President's Prize, Lady Captain's Prize, President's Prize to Ladies or Captain's Prize to Ladies.
5. Introductory Membership is not available to playing members of Carlow Golf Club.
6. Introductory Members are not entitled to Leave of Absence.
7. Introductory Members may not propose or second a candidate to any category of membership.
8. Carlow Golf Club reserves the right to change any of the above conditions at any time.
